Main goals of the goMURra project

- Flood protection (to protect/improve land areas close to the borderstrech of the Mura river from overflow – minimise of damage caused by flooding; structural flood mitigation measures
- Increase the level of awareness and preparedness /action at flood events (Disaster relief plan "Border Mura"; alarm plans and operational plans)
- Find solutions to **improve hydro-morphological condition** of Border Mura:
 - prevent further deepening of the river bed,
 - prevent further decrease of groundwater level,
 - revival of side alarms and mill channels,
 - improvement of habitat condition
